# WHAT DOES GENTRY PRIVATE WEALTH, LLC ("GPW") DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Government ID, such as Social Security number and/or Driver's License number
- Account balances and transaction history
- Income, investment experience, and account transactions

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons GPW chooses to share; and whether you can limit this sharing.

How does GPW protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.	
	■ GPW does not share with our affiliates	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.	
	■ GPW does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  GPW does not jointly market.	

## Other important information

For CA residents: We will not share personal information we collect about you with nonaffiliated third parties, except as permitted by law, including, for example, with your consent or to service your account. You may limit our sharing of such information with affiliates by contacting us as set forth above.

For VT residents: We will not share personal information we collect about you with nonaffiliated third parties or affiliates, except as permitted by law, including, for example, with your consent or to service your account.
